



ADVENT CALENDAR FREE PRIZE DRAW

Terms and conditions

Please read these competition rules carefully. By entering a competition you are deemed to accept and be bound by these terms and conditions.

1. To enter a competition you must be: (a) Berkshire and neighbouring counties, UK resident; and (b) aged 18 years or over at the time of entry.
 2. Competitions are not open to employees (or members of their immediate families) of the Promoter, its agencies or anybody connected with the competitions.
 3. No purchase necessary to enter.
 4. The four competitions will run from 12 noon on 30 October to midnight on Sunday 26 November (the 'competition period'). Entry details relating to each competition will be posted on Facebook but advertised/promoted on Instagram and The Lexicon website.
 5. To participate in the competition, entrants should visit www.facebook.com/TheLexiconBracknell, follow the entry instructions by tagging a friend on the promotional post. Entries must be submitted no later than midnight on the day the entry closes.
 6. Only one entry per person or Facebook account per competition.

 9. Each competition result is final and no correspondence will be entered into, except with the winner. An entry containing any obscene, offensive, libellous or anti-social content will be removed from the Facebook competition page and the person submitting such entry will be disqualified from all competitions being run by the Promoter during the competition Period.
