Terms & conditions

Please read these promotion rules carefully. By entering a promotion, you are deemed to accept and be bound by these terms and conditions.

- 1. To enter a promotion, you must be: (a) UK resident; (b) aged 18 years or over at the time of entry and (c) complete the short survey on the reverse of the entry forms.
- 2. The promotion will run from 9am Saturday 16 November to midnight Sunday 5 January 2025 (the 'Promotion Period').
- **3.** To participate in promotion, and to qualify for entry, entrants must hand-in the completed forms including the survey section on the reverse (the 'Completed Forms') into the red post-box outside YiFang on The Avenue.
- 4. Closing date is midnight on Sunday 5 January 2025.
