## Terms & conditions

Please read these promotion rules carefully. By entering a promotion, you are deemed to accept and be bound by these terms and conditions.

1. To enter a promotion, you must be: (a) UK resident; (b) aged 18 years or over at the time of entry and (c) complete the short survey on the reverse of the entry forms.
2. The promotion will run from 9am Saturday 16 November to midnight Sunday 5 January 2025 (the 'Promotion Period').
