## **Terms & conditions**

By submitting an entry, you are deemed to accept and be bound by these terms and conditions.

- 1. Entrants can be of any age but if under 16, the consent of a parent or guardian will be required.
- 2. Entrants must live within Bracknell Forest or neighbouring districts.
- **3.** By submitting an entry you are giving The Lexicon permission to use the design and/or idea you submit to create a game vinyl.
- 4. Please note that design amends may be made to the original design submitted
- **5.** We will need your full name, email address and contact number. The information you provide will be used to administer the campaign and print the artwork.
- **6.** We will keep your personal information secure and will process it in accordance with all applicable data protection legislation.
- **7.** For further information about how we handle your personal data, including in relation to your rights, please see our privacy policy.
- 8. Closing date for entries is midnight on Sunday 29 September 2024.
- **9.** Entries must be submitted via the website www.thelexiconbracknellcom/vinyl or handed to reception at The Lexicon Management Suite, lower ground floor of The Avenue Car Park, Bracknell.
- 10. There is one prize to be won. A £500 gift card from The Lexicon.
- **11.** Promotions are not open to employees (or members of their immediate families) of the Promoter, its agencies or anybody connected with the promotions.
- 12. No purchase necessary to enter.
